- Each TBRU represents a contingent right to receive the value of one share of A. H. Belo Corporation Series A Common Stock. TBRUs are valued as of the date of vesting and are paid 60% in shares of A. H. Belo Corporation Series A Stock and 40% in cash.
- The number of shares shown represents settlement of the 40% cash portion of TBRUs that vested and were paid on February 25, 2011. Pursuant to SEC guidance settlement of the cash portion is deemed a disposition of shares to the Company.
- Held by the A. H. Belo Savings Plan as of February 25, 2011.
- These TBRUs were awarded on January 28, 2010.
- Vesting of the January 28, 2010 award is as follows: 40% of the award vested on February 25, 2011, the third trading day following the annual earnings release date for the fiscal year ending December 31, 2010; the remainder of the award will vest 30% on the third trading day following each annual earnings release date for the fiscal years ending December 31, 2011 and 2012. Each tranche is settled within 10 business days after vesting.
