- The number of shares shown represents the settlement of the 40% cash portion of TBRUs that vested and were paid on February 24, 2012. Pursuant to SEC guidance settlement of the cash portion is deemed a disposition of shares to the Company.
- The number of shares shown represents the time-based restricted stock units TBRUs that vested and were paid on February 24, 2012. These TBRUs were awarded on March 9, 2011.
- These TBRUs were awarded on January 28, 2010.
- These TBRUs vest 100% and are paid on the third trading day following the annual earnings release date for the fiscal year ended December 31, 2011.
- These TBRUs were awarded on March 9, 2011.
- The reporting person disclaims beneficial ownership of these securities.
